# **President's Report**

Today on CWS's 32<sup>nd</sup> AGM is also Australia's referendum to the proposed change to the Australian Constitution – whether to alter the Constitution to recognise the First Peoples of Australia and Torres Strait Islander Voice. A "double majority " is –

- a national majority (more than 50%) from all states and territories, and
- a majority (more than 50%) in a majority of states (at least four of the six states).

This is also my near 30<sup>th</sup> year (29 years) volunteering at CWS since I retired from full time work in 1994!

Confucius said in his analects:

吾十有五而志乎学,三十而立,四十而不惑,五十而知天命,六十而耳顺,七十而从心所欲不 逾矩

"At 15 I set my heart upon learning; at 30, I had planted my feet at 40, I no longer suffered from perplexities; at 60, I had them with docile ear; at 70, I could follow the dictates of my own heart; for what I desired no longer overstepped the boundaries of right! "

Thus, it is with these feelings that I bid farewell to all of our members, it has been a journey well-travelled by all of us and got CWS to today's position of providing a much needed care for our community with a staff force of over 35 with bilingual languages for our Chinese communities viz:

# Home care packages (HCP) to care for older people with complex care needs to live independently in their own homes – with over 150 care recipients and 15 on the waiting list. # Commonwealth Home Support Program (CHSP) – provides entry-level support for older people from social support to domestic assistance – with over 220 consumers.

# Aged Care Volunteer Visitors Scheme (ACVVS) - This scheme involves volunteers visiting older people either in their own homes or in a residential aged care facility (RACF). With some 60 older Chinese in RACF, we provide a much needed community contact with people of similar age and background

# Integrated Carer Support Service (ICSS) – provide support to the many carers of the frail and aged

# CWS Chinese Language School – provide a second language support of cultures and festivities to the 160 students enrolled in our Saturday 1.30 to 3.30 pm classes.


# Since 2019 of the pandemic, our interest classes and special projects have been in recess and I sincerely hope that that will change with time and a new batch of eager volunteers! # We have continued with research collaborations with Flinders University's Social Sciences Faculty on Dementia care for Chinese community in Oceania; mental health and disability

care for the CALD community.

This is a year that sees us consolidate our programs with an audit review according to the Aged Care Standards to ensure that we are compliant in our conduct and operations. As you can see from CWS' Financial report, we have put away a significant amount for future improvements- notably may be new Software Management System and professional development and training for staff and volunteers.

I am very honoured to have so many volunteers (about **90** of them, from volunteer teachers at our ethnic Chinee language school to our portfolio of volunteers) who have risen up to the occasion in helping CWS deliver so much assistance to our community. We will be recognising them today with a certificate of acknowledgement from the Minister of Volunteer – Ms Nat Cook MP and a Coles voucher as in CWS tradition!

In 2022-2023, we have **106** Life members; and **248** ordinary members totalling 354 members.

As you see from the chart- the majority of our members are in the 61 to 80 yrs group! So if you have any friends who are over 60 yrs, come to see us! We have lots of programs that will meet your social and psychosocial needs.

We also like to remember those members who have passed in the last 12 months: **5** members: 4 over 90 years and 1 over 80 years. Vale!

With the ensuing months ahead in 2023 and 2024, we hope to pursue probably new premises as we now have some 8 full time staff plus a 500 hours Social Work placement student! The front office is certainly a challenging working environment.

We have a contract with Flinders University with placement of their Master of Social Work student for 500 hours; Uni SA have sought our partnership too! But we really don't have the physical space to accommodate them. As you can see, we certainly have the workload to provide work experience though our staff need support – both in training capacity and the mentorship capability.

We have purchased a new Optus telecommunication system that provides us with X6 loop lines and a much more robust NBN network making communications much easier. This will reduce our need for 11 mobile phones to only 4!

As you can see from the financial report, we have a healthy surplus of over **700K**. The Board has agreed to put aside \$450k to future development as indicated above.

Looking forward to continued growth and our pledge to support and assist our community.

The 2023 Intergenerational Report provides a big picture view of the forces that will shape our economy and fiscal position over the next 40 years.

By 2062-63; our economy is projected to be around 2.5 times larger and income 50% higher in real terms. Australians are living longer in full health and more time using government-funded services. Increased longevity, alongside low fertility rates, means the population will continue to age over the next 40 years. The number of people aged 65 and over will more than double and the number aged 85 and over will more than triple! Population ageing will be an ongoing economic and fiscal challenge. Commensurate with that a rising demand for care and support services will grow in skills, training and a wage that reflects the value of care work will be critical to attract and retain the workforce for the needed expansion in the sector.

Australia's population will rise to around 40.5 million with a longer life expectancy of men will rise from 81.3 years (2023) to 87 years (2063) and women from 85.2 years (2023) to 89.5 years (2063). The report focuses on the impact of 5 of the significant forces expected to reshape Australia's economy in coming decades:

- population ageing
- rising demand for care and support services
- climate change and the net zero transformation

Cochang

- · technological and digital transformation, and
- · geopolitical risk and fragmentation.

My wishes for the Board in the next 12 months are:

- Purchase of a home base for CWS I invite the Ministers and friends here at our AGM to help us scout for a premises – my scope is meagre – to have office accommodation for our staff; a kitchen that we could expand to allow us to provide delivered meals to our community and a community hall for meetings!!
- Further professional development training for CWS community on Aged Care Standards and their implications and applications
- Continue our collaboration with the tertiary institutions in research for care for the aged in a multicultural environment,
- Continuous recruitment of bi-lingual staff and allied health specialists to provide care for our community.
- Continuous liaison with main stream Aged Care services to navigate the new Aged Care Act; Aged Care Standards and
- Continue with our collaboration with Bene Aged Care St Agnes to introduce our seniors to the facility as the Chinese community do not have a care specific residential centre.


# 我们继续与弗林德斯大学社会科学学院就澳大利亚华人社区的痴呆症护理开展研究合作。

我非常荣幸有这么多志愿者(其中大约 90 名,从我们汉语学校的志愿者教师到我们的志愿者组合)挺身而出,帮助福利会为我们的社区提供如此多的援助。今天,我们将按照福利会的传统,向他们颁发志愿者部长 Nat Cook MP 女士颁发的感谢证书和 Coles 代金券!

## Membership Profile By Age 2022-2023



正如从图表中看到的-我们的大多数会员都在 61 至 80 岁年龄段!所以如果你有 60 岁以上的朋友,就来看看我们吧!我们有很多计划可以满足您的社交和心理需求。

我们在这里缅怀过去 12 个月内去世的成员:5 名成员:4 名超过 90 岁,1 名超过 80 岁。

在 2023 年和 2024 年接下来的几个月里,我们希望寻求新的办公场所,因为我们现在有大约 8 名全职员工和一名 500 小时社会工作实习的学生!前台办公室无疑是一个充满挑战的工作环境。

我们与弗林德斯大学签订了一份合同,安排他们的社会工作硕士学生进行 500 个小时的实习; Uni SA 也寻求我们的合作伙伴!但我们确实没有空间来容纳他们。正如所看到的,尽管我们的员工需要培训能力和指导能力方面的支持,但我们当然有能力来提供工作经验。

我们购买了新的 Optus 电信系统,该系统为我们提供了 6 条环路线路和更强大的 NBN 网络,使通信变得更加容易。这将使我们对 11 部手机的需求减少到只有 4 部!

正如从财务报告中看到的,我们有超过 **70** 万的盈余。如上所述,董事会已同意拨出 **45** 万元用于未来 开发。

期待持续增长并承诺支持和帮助我们的社区。

来自 2023 年政府跨代报告,该报告提供了未来 40 年经济和财政状况的全局视图!

到 2062-63 年;按实际价值计算,我们的经济预计将增长约 2.5 倍,收入将增长 50%。澳大利亚人的健康寿命越来越长,使用政府资助服务的时间也越来越多。寿命的延长和生育率的降低意味着未来 40 年人口将继续老龄化。 65 岁及以上的人口数量将增加一倍以上,85 岁及以上的人口数量将增加两倍以上!人口老龄化将是一个持续的经济和财政挑战。与护理和支持服务不断增长的需求相适应的是,技能、培训和反映护理工作价值的工资对于吸引、留住劳动力以实现该行业所需的扩张至关重要。澳大利亚人口将增至约 4050 万,男性预期寿命将从 81.3 岁(2023 年)延长至 87 岁(2063 年),女性预期寿命将从 85.2 岁(2023 年)延长至 89.5 岁(2063 年)。该报告重点关注了预计在未来几十年重塑澳大利亚经济的五种重要力量的影响:

- 人口老龄化
- 对护理和支持服务的需求不断增长
- 气候变化和零排放
- 技术和数字化转型,以及
- 地缘政治风险和分裂。

- 不断招募双语工作人员和专业医疗专家为我们的社区提供护理。
- 与主流老年护理服务机构持续保持联系,以适应新的老年护理法案; 老年护理标准和
- •继续与 Bene Aged Care St Agnes 合作,向我们的老年人介绍该设施,因为华人社区没有专门的护理



#### Home Care Packages (Funded by Department of Health)

Home Care Package (HCP) is a Commonwealth government-funded programme aiming at supporting eligible aged people, allowing them to maintain their dignity, independence and safety when they live in their home. CWS has been providing HCP services since late 2017, and now we are stepping into the sixth year. By working with more consumers, CWS has gained more knowledge, experiences and resources to provide care. This report will show you the key changes to our HCP for the last financial year.

There was an ongoing increase in the number of HCP consumers for the 2022 - 2023 financial year. Compared to the number of HCP consumers in June 2022, the number in June 2023 had increased by 20, with a total number of 147 people. In addition to providing support to people who chose CWS as their services provider, CWS also assists aged people who are eligible but find it challenging to access My Aged Care with applying for HCP services. This helps CWS build a strong relationship with them. By the end of June 2023, more than 20 consumers expressed interest in starting their HCP with CWS.

#### **Stronger CWS HCP Team**

In order to provide competent care and package management, CWS recruited more professional and passionate people to join our team. CWS currently has 4 full-time care coordinators, two full-time administration officers; 3 Registered Nurses (casual), one Enrolled Nurse, and 36 support workers.

To ensure our working team compliance with the Aged Care Quality Standards, CWS provides ongoing compulsory training in each month covering topics related to standard 1 to standard 8.

To ensure our care team provides competent clinical care, CWS has ongoing clinical advisory meetings to provide clinical advices, monitor clinical incidents and general service advices.

#### **Appreciation**

For the past financial year, CWS was very grateful that we could walk along with our HCP consumers and support them to live in their familiar environments. We appreciate your support and understanding and will endeavour to pursue a better care for you.

#### **Community Visitors Scheme** (Funded by Department of Health)

#### Program Objective:

The Community Visitors Scheme provides volunteer visitors to visit recipients of Australian Government subsidized aged care services (Aged care facility or home care package) who are socially isolated and whose quality of life would be improved by friendship and companionship. 23 CVS visitors have actively contributed to the scheme in the last financial year, 28 service recipients have gained friendship and companionship from visitors' contribution.

# **Community Language Chinese School Report**

Teaching and learning at the school were augmented to align with the Department of Education's standards and regulations followed by all public schools. Teachers planned and prepared face-to-face classes while families continued to support their children to learn Mandarin within both the home and school environment.

Our Chinese Community Language School, located at Adelaide High School (AHS), has met, along with other school communities, on a weekly basis. The classroom space and facilities are ideally suited both teachers and students to carry out the Chinese language and cultural programs.

The achievements in this past year have been significant, especially in the early R-5 classes and the senior language and cultural programs by providing a renewed curriculum based on renewed lessons prepared by volunteer teachers throughout this year. Of particular interest and success was the play - The MAGIC BRUSH.

This play was performed with students at all levels from our school. Teachers contributed and dedicated their weekend time to rehearse the play with students. Our school was grateful that the parents supported the students throughout the year. We participated and presented the play at the Children's Week e-Concert at the end of 2022. The practice of the play was a challenging task for both teachers and students but the play was successfully and presented and shared on-line.

#### Report on the Financial Report

I have reviewed the accompanying financial statements, being a special purpose financial report, of Chinese Welfare Services of SA Incorporated (the association) that comprises an income account and a detailed profit & loss statement for the year ended 30 June 2023 and a balance sheet as at that date.

#### Committee's Responsibility for the Financial Report

The committee of the association is responsible for the preparation of the financial report that gives a true and fair view and has determined that the accounting policies used are appropriate to meet the requirements of the *Australian Charities and Not-for-Profits Commission Act 2012* (ACNC Act) and the needs of the members. The committee's responsibility also includes such internal control as the committee determines is necessary to enable the preparation of a financial report that gives a true and fair view and is free from material misstatement, whether due to fraud or error.

#### Auditor's Responsibility

My responsibility is to express a conclusion on the financial report based on my review. I conducted my review in accordance with Auditing Standard on Review Engagements ASRE 2415 Review of a Financial Report: Company Limited by Guarantee or an Entity Reporting under the ACNC Act or Other Applicable Legislation or Regulation, in order to state whether, on the basis of procedures described, anything has come to my attention that causes me to believe that the financial report does not satisfy the requirements of Division 60 of the ACNC Act including: giving a true and fair view of the registered entity's financial position as at 30 June 2023 and its performance for the year ending on that date.; and complying with the Australian Accounting Standards and the Australian Charities and Not-for-Profits Commission Regulation 2013 (ACNC Regulation). ASRE 2415 requires that I comply with the ethical requirements relevant to the review of a financial report.

A review of a financial report consists of making enquiries, primarily of persons responsible for the financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with Australia Auditing Standards and consequently does not enable me to obtain assurance that I would become aware of all significant matters that might be identified in an audit. Accordingly, I do not express an audit opinion.

#### Independence

In conducting my review, I have complied with the independence requirements of Australian professional ethical pronouncements.

#### Basis for Qualified Conclusion

Donations are a significant source of revenue for the Chinese Welfare Services of SA Incorporated. The Chinese Welfare Services of SA Incorporated has determined that it is impractical to establish control over donations prior to entry into its financial records. Accordingly, as the evidence available to me regarding revenue was limited, my review procedures with respect to donations had to be restricted to the amounts recorded in the financial records. I therefore am unable to conclude whether the recorded donations of Chinese Welfare Services of SA Incorporated are complete.
